### CORRECTIVE SERVICES (CHAPTER 8)


- The focus of this chapter is on prison custody and a range of community corrections orders and programs for adult offenders.
- In 2009-10, on average, 28 956 people per day were held in Australian prisons. In addition, 882 people on average were serving periodic detention orders in NSW and the ACT (p. 8.5). Nationally, 18 per cent of the total prisoner population (excluding periodic detainees) were held in privately operated facilities (p. 8.5).
- Nationally, an average of 57 518 offenders per day were serving community corrections orders in 2009-10 (p. 8.9).
- Nationally, total net recurrent expenditure on corrective services (net of operating revenue and excluding payroll tax and expenditure on transport/escort services) was \$3.3 billion in 2009-10 (p. 8.3).

### Objectives of corrective services


- Corrective services contribute to the whole-of-government priority, in all jurisdictions, to create safer communities through the administration of correctional sentences and orders. In summary, the objectives of corrective services are to:
- provide a safe, secure and humane custodial environment
- provide an effective community corrections environment
- provide program interventions to reduce the risk of re-offending.

Completion of community corrections orders, by type of order, 2009-10<sup>a</sup> (p. 8.31)




Real net operating expenditure per prisoner per day (2009-10 dollars)<sup>a</sup> (p. 8.25)
