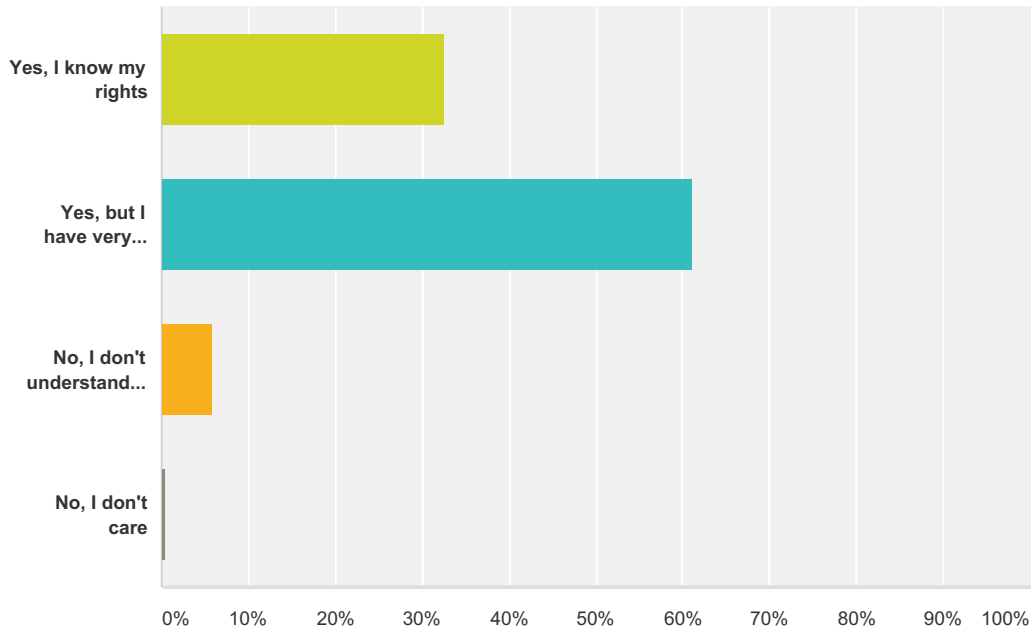


Q1 Do you know your copyright rights?

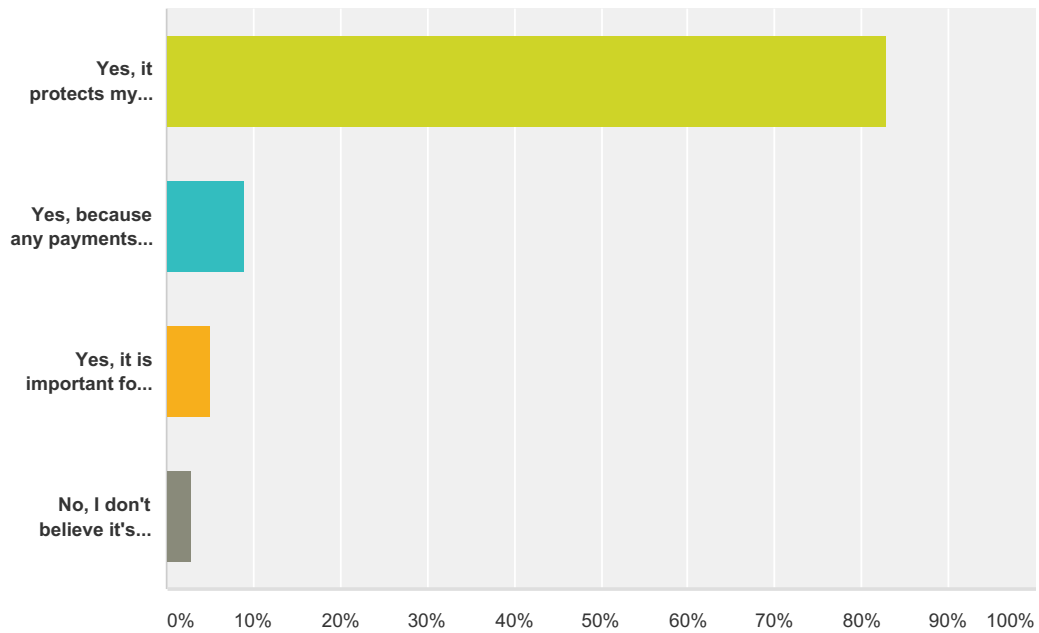

Q2 Do you believe copyright is an important right for artists to have?

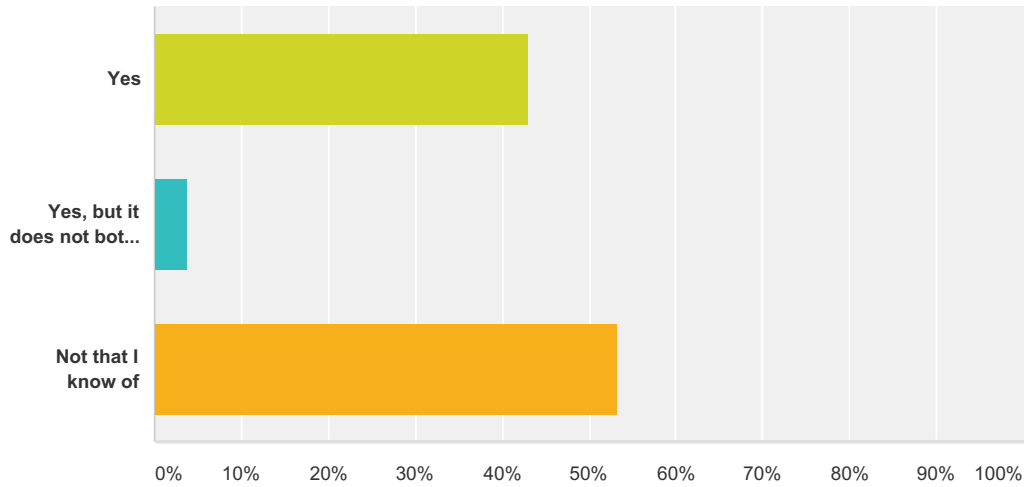

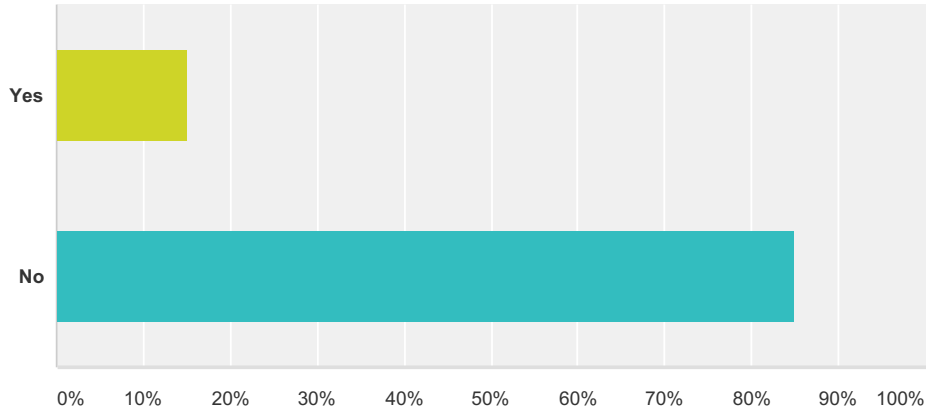

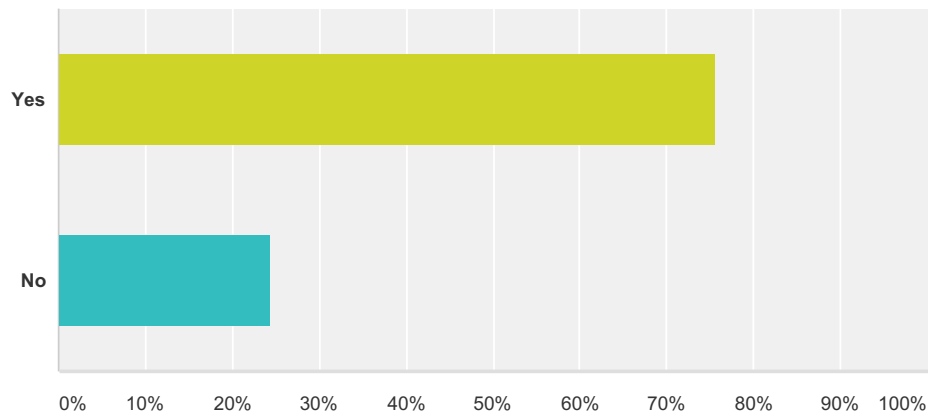

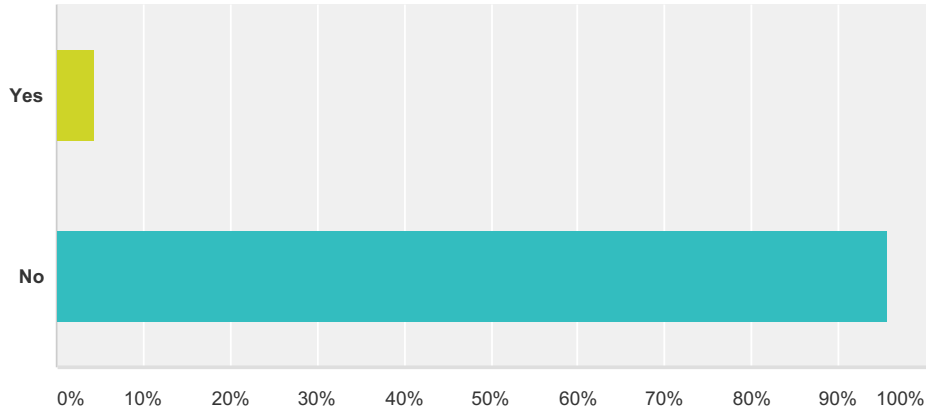

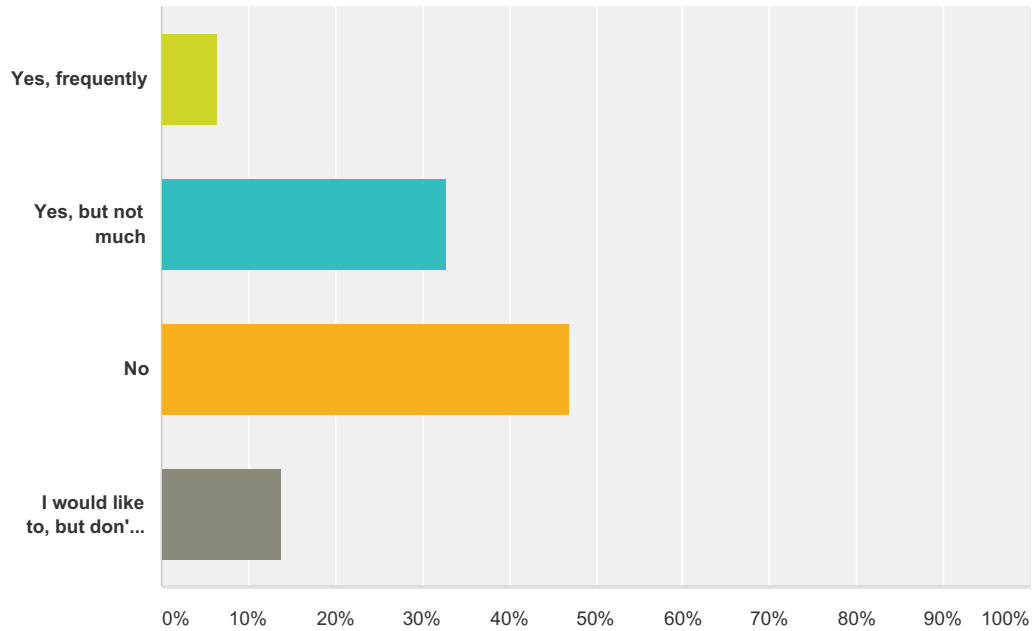

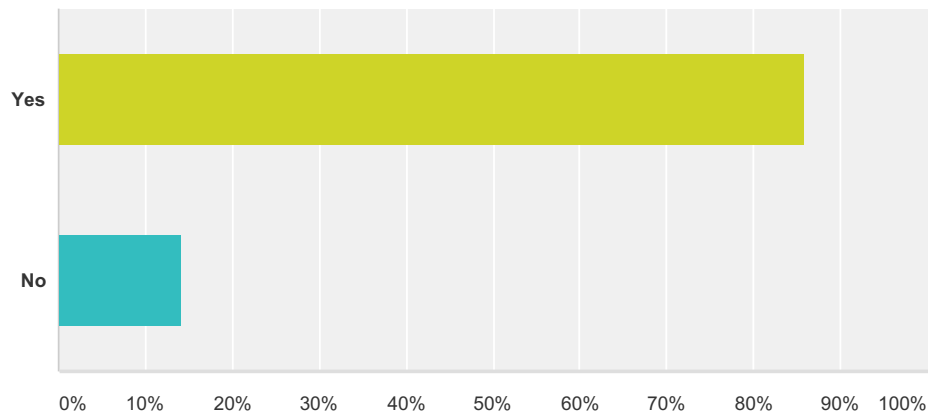

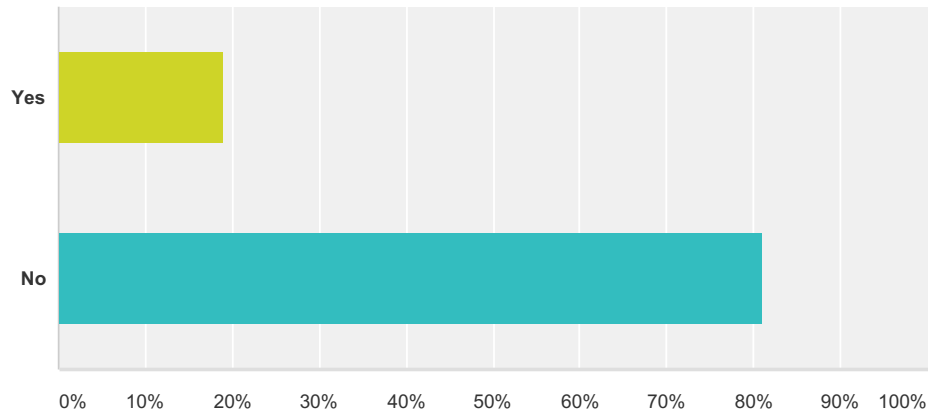
