Dear Chairman Harris,

On behalf of the Ministry of Economic Affairs of Taiwan, I would like to submit its comment on Australia's notification to the Committees on Safeguards of the World Trade Organization (G/SG/N/6/AUS/4) of safeguard investigation against import of Certain Processed Fruit Products (2008.30.00, 2008.40.00, 2008.50.00, 2008.70.00, 2008.97.00, 2008.99.00).

As to the products concerned and pursuant to the World Trade Atlas statistics, my government would like to point out the average import shares of the above mentioned products from Taiwan between 2010 and 2012 (0.72%, 0.10% and 0.06% respectively) were significantly small and below the threshold of 3% of the total importation into Australia. Attached please find the individual data of concerned products imported from Taiwan for your reference. Therefore, my government contends that an exemption from the safeguard measures should be conferred upon these Taiwanese products according to Article 9.1 of the Agreement on Safeguards.
