OUR CENTRE

Bowden Park is the headquarters of Aspley Little Athletics Centre Inc. affiliated with Queensland Little Athletics Assn. Inc. the State Little Athletics body. The Centre was founded in 1980/81 and was incorporated on 9 August 1984.

Our current 2008/09 Season started on 6 September 2008. On Saturday 14 March we had 316 children registered with QLAA and 67 Athletes registered with Queensland Athletics through our Senior Club Aspley Athletics Club Limited which we incorporated on 7 August 2002. The Directors of that Club are all Life Members of our Centre, save for two Directors who are QA athletes, coaches and members of the Little Athletics Centre.

We are presently in the later part of our Centre Season. On Saturday 14 February we successfully held our Annual General Meeting and elected a Management Committee of 21 members. We held Bring a Friend Day on Saturday 27 September and Annual Kedron Wavell Services Club Pentathlon was held on Sunday 12 October. We compete at our home ground each week – Saturdays between 9.00am and Noon from 6 September to 29 November 2008 and 14 February to 4 April 2009; Fridays 5.30pm – 9.00pm from 5 December 2008 to 30 January 2009 under lights to avoid the heat in accordance with our Sun Safe Policy and train Monday and Wednesday nights under lights between 5.30pm to 7.00pm. Our QA Athletes then train on Monday and Wednesday nights from 7.00pm to 9.00pm.

At the Kedron Wavell Services Club Pentathlon on 12 October children from 18 Centres took part

Our 2008/09 Season will conclude on 4 April 2009.

EQUITY

In the current 2008/09 Season a large component of our registrants are girls, we have many women parent members a number of these are single parent family. 9 women were elected on our Management Committee on Saturday 14 February. 8 of our qualified parent coaches are women, and a number of women became qualified officials. We have children and parents in each of the equity groups. A number of our Little Athletes, are disabled and have been with us a number of years.

We make our facilities available on Saturday afternoon each week to a group of disabled athletes, approximately 20, to train – Brisbane North Special Olympics – under the supervision of one of our former coaching officers.

SHARED FACILITIES

Our Centre has arrangements, whereby our facilities are shared with Athletics North Brisbane Club affiliated with the State senior body – (Queensland Athletics Ltd) and that Club trains at Bowden Park on Thursday nights throughout the year under lights and contribute to the cost of lighting used.

Our Centre has for many years been concerned that our Senior Athletes have had to leave the Centre and Little Athletics at the end of Summer Season of their 15 year.

However, while some continued in School Athletics for a short time, most dropped out of the Sport because they missed the structured training and competition and most of all the caring family atmosphere and friendship of the Centre.

In an endeavour to rectify this Aspley Centre formed Aspley Athletics Club Limited which was incorporated on 7 August 2002.

Aspley Athletics Club trains during our Summer Season on Monday and Wednesday nights from 7.00pm to 9.00pm and the Athletes compete with our Little Athletes in our Friday/Saturday competitions which have been sanctioned by both QA and QLAA. Other members of our Club compete at QA events at QSAC track, U of Q track and Gold Coast track to State and National level. In the remainder of the year those QA Athletes train Monday & Wednesday nights from 5.30pm to 9.00pm and compete at Cross Country events conducted throughout Brisbane and its environs.

Aspley Athletics Club has been a success. Our registrations in December of the last year were 67 athletes

An independent Athletics squad is coached by Steve Zacca, one of our neighbours on the corner of Bateman & Maidencombe Streets, at least twice a week. Whenever I mow the field I see other small family groups or squads training and the teachers and students of St Kevin's School use the track and field very regularly.

During the school Athletics Season there is great demand on our facilities by both local and regional schools and these are made available at nominal costs. We often provide, free, our qualified parent officials. The last report which I prepared detailed the school usage during 2004 and 2005 season.

When formal training etc. is not in progress the public have access to the Park which receives heavy usage from individual Athletes on an informal basis and by local residents and casual walkers etc.

KEDRON WAVELL SERVICES CLUB SUPPORT

Without the support of the KWSC Aspley Centre faced a very bleak financial situation. Our Centre would not have been able to meet our Vision Statement and certainly would not have been anywhere near as successful as it has been. The relationship started in 1995 when the Centre obtained a grant from GMCBF of \$10,791.00 for flood lightning and KWSC contributed \$5,000.

At our Centre's Annual General Meeting on 19 February 2000, I reported:

1. Including Kedron Wavell Services Club's assistance for coaching which I reported on earlier the Club subsidized the Centre a total of:-

- 2. H. During 1996, Aspley Centre received from Kedron Wavell Services Club for Coaching Education, Registration and Delivery \$15,645.00
 - I. During 1997, The Centre received from Kedron Wavell Services Club for Coaching Education, Registration and Delivery \$10,791.00.

- J. During 1998, The Centre obtained from Kedron Wavell Services Club for Coaching Education, Registration and Delivery \$13,394.00.
- K. During 1999, The Centre obtained from Kedron Wavell Services Club for Coaching Education, Registration and Delivery \$13,443.00.
- In our negotiations with Athletics North and Kedron-Wavell, the Club agreed to cover the Queensland Athletics costs of our U13/14/15 children wanting dual membership, 12 of our children took up that offer in 1997 but only 6 in 1998 and 4 in 1999. I firmly believe that this is one way we can smooth the Little Athletes path to senior athletics and help friends stay together.
- 4. In addition the Club stood behind the Centre in all our applications for subsidy Government and Council. The Club agreed to stand behind the Centre for \$20,000 to cover the cost of the additional area to allow the high jump to be extended to 15M radius. It was anticipated that those funds would be needed in July 1998. But due to active fundraising by our Centre Parents, it was not necessary to call on the Club for those funds.
- 5. Kedron Wavell donated the colour TV prize for our Townsville raffle which gave us \$3,270.00.
- 6. The Club also made us a gift of \$1,095.00 to purchase the petrol driven tiller for our long jump pits.
- 7. Kedron Wavell Services Club stood behind our application under the 1999 Minor Sports Facilities Program to duplicate the long jump synthetic runways and pit, subsoil drainage of infield and extend sprinkler system and has paid \$16,949.00 being 50% of the costs to date.

At our Centre's Annual General Meeting on 17 February 2001, I reported:

- 1. During 2000, the Centre obtained from Kedron Wavell Services Club for Coaching Education, Registration and Delivery \$11,843.15.
- 2. In our negotiations with Kedron Wavell, the Club agreed to cover the Queensland Athletics costs of our U16/17 children. 12 of our children took up that offer.
- 3. Kedron Wavell Services Club stood behind our application under the 1999 Minor Sports Facilities Program to duplicate the long jump synthetic runways and pit, subsoil drainage of infield and extend sprinkler system and has paid \$35,536.00 being 50% of the costs between 7 October 1999 and 11 May 2000.
- 4. In August 2000 Kedron Wavell again gave us the TV & Video for our raffle which netted \$2,841.70.
- 5. Including Kedron Wavell Services Club's assistance for coaching which I reported on earlier the Club subsidized the Centre a total of:-

At the Centre's Annual General Meeting on 16 February 2002, I reported:

- 1. When the extensions of the shed was in progress we approached the Club for assistance to purchase hurdles etc. for QA Athletes and purchased it from Nordic Sports. Kedron Wavell kindly agreed to meet these costs which we paid on 5 October 2001 at total of \$15,316.50.
- 2. During 2001, The Centre obtained from Kedron Wavell Services Club for Coach Education, Registration and Delivery \$14,355.65.
- 3. In August 2001, Kedron Wavell again gave us the TV & DVD Combo for our raffle which netted \$3,516.94 after paying \$511.06 for printing and advertising.
- 4. Including Kedron Wavell Services Club's assistance for Coaching that Club subsidized the Centre a total of:-

and as I reported at paragraph 10 on page 14 Kedron Wavell also paid \$15,316.50 for the new QA equipment in October 2001.

At the Centre's Annual General Meeting on 22 February 2003, I reported:

- 1. In August 2002, Kedron Wavell again donated these prizes \$1,098.00 for our Townsville raffle. We netted \$3,980.81 giving us a total of \$8,752.46 which allows us to subsidize our qualifiers bus fare by \$100.00
- 2. Including Kedron Wavell Services Club's assistance for Coaching which I reported on earlier the Club subsidized the Centre a total of:-

and as I reported last year Kedron Wavell also paid \$15,316.50 for the new QA equipment in October 2001.

At the Centre's Annual General Meeting on 21 February 2004, I reported:

- During 2003, the Centre obtained from Kedron Wavell Services Club for Coach Education, Registration and Delivery \$16,091.16.
- 2. The 2003/04 Raffle is much more valuable. We grossed \$4,038.40.
- 3. In 2003, the KWSC Club paid \$16,135.90 for the discus cages and nets.

At the Centre's Annual General Meeting on 19 February 2005, I reported:

- 1. September 2003, Construction Hammer/Discus cage; Discus cage, nets and conversion circle \$36,669.30 OSR \$23,533.40 KWSC \$16,135.90.
- 2. During 2004, the Centre obtained from Kedron Wavell Services Club for Coach Education, Registration and Delivery \$17,051.00.
- 3. In 2004, Kedron Wavell donated a \$2,000.00 travel raffle. These were issued as Parents signed on. We grossed \$3,320.55.

4. During 2004, Kedron Wavell has supported us to the amount of \$54,057.51.

At the Centre's Annual General Meeting on 18 February 2006, I reported:

- 1. During 2005, the Centre obtained from Kedron Wavell Services Club for Coach Education, Registration and Delivery \$20,067.70 (+GST)
- 2. In 2005, Kedron Wavell again donated a \$2,000 travel raffle and the Committee agreed to issue one book per family at sign-on and increase fees by \$10.00.
- 3. During 2005, Kedron Wavell has supported us to the amount of \$57,161.31 (incl GST).

At the Centre's Annual General Meeting on 17 February 2007, I reported:

- 1. During 2006, the Centre obtained from Kedron Wavell Services Club for Coach Education, Registration and Delivery \$21,257.75 (+GST).
- 2. In 2005 Kedron Wavell again donated a \$2,000 travel raffle and the Committee agreed to issue one book per family at sign-on and increase fees by \$10.00 but this was not really successful as books were outstanding despite 2 letters to parents.
 - In 2006 the Centre decided to increase our fees by \$15.00 and give each family 10 tickets in the Travel Raffle. This has been a success.
- 3. During 2006 Kedron Wavell has supported us to the amount of \$58,611.00 (incl GST).

At the Centre's Annual General Meeting on 16 February 2008, I reported:

- 1. During 2007, the Centre obtained from Kedron Wavell Services Club for Coach Education, Registration and Delivery \$16,212.81.
- 2. Since 1998, Kedron Wavell has donated prizes for our Sign-on raffles.
- 3. During 2007, we have claimed \$48,661.30 + (GST) from Kedron Wavell.

At the Centre's Annual General Meeting on 14 February 2009, I reported:

- 1. To September 2008, the Centre obtained from Kedron Wavell Services Club for Coach Education, Registration and Delivery \$9,687.92.
- 2. All these improvements effected since 1983 come out of Fund Raising and Sponsorship, grants from Office of Sport, grants from Gaming Machine Community Benefit Fund Gambling Community Benefit Fund, Commonwealth Government Water Grants, and Kedron Wavell Services Club
- 3. In September 2002 with the loss of our steady regular Fund Raising Sources Aspley Centre faced a very bleak financial situation if it were not for the exceptional support which we got from Kedron Wavell Services Club.
- 4. Under the heading of Coaching, I have touched on the support we have got from Kedron Wavell in that respect.
 - During 2007, we claimed and received from Kedron Wavell \$48,661.30 + GST.

- 5. In September 2008 Kedron Wavell agreed to formalize the arrangements it had with Aspley Little Athletics Centre (and also with Aspley Athletics Club) to provide
 - . ALA a sponsorship fee of \$40,000 (incl GST) per annum payable to ALA in two instalments as follows:

 - Instalment 1 on September 30^{TH} 2008 \$20,000 (inc. GST) Instalment 2 on January 31^{ST} 2009 \$20,000 (inc. GST) and
 - . ALA net funds (inc GST) generated from the weekly raffle payable to ALA in quarterly instalments as follows:
 - Instalment 1 on December 31ST 2008

 - Instalment 2 on March 31ST 2009 Instalment 1 on June 30TH 2009 Instalment 1 on September 30TH 2009
