Thank you for the opportunity to provide a submission.

The data set out below attempts to summarise the valuable contribution the Forbes Services Memorial Club (FSMC) makes to the community. For many it is their social centre and represents the only family they have.

9 years ago the FSMC amalgamated with the Forbes Golf Club which was in financial difficulty at the time and in danger of closing. Considerable funds have been utilised by the FSMC propping up the Forbes Golf Club site in order to maintain it as an important community facility. Unfortunately with the imposts of increased gaming taxes, smoking legislation and the drought, the FSMC has had to relinquish its financial support of the Forbes Golf Course side of the operation. At this stage we are continuing to operate the Forbes Golf Clubhouse however our ability to support this operation is also under pressure and further imposts on the Clubs industry would severely affect our ability to continue to run this site.
