Thank you for the opportunity to provide a submission on behalf of the Finley Bowling Club. The Club premises are located on the junction of the Newell and the Riverina Highways. It was established and opened its activities on 20. 11 1948, with the club charter of "promoting the game of bowls for Finley and district people". It is a mixed club(ladies and men), and has 477 members, 77 playing members and 400 social members. There are 2 tift dwarf greens established.

In order to provide entertainment for members and visitors, or to create a social outing Atmosphere, 20 poker machines and Keno gaming is available for use, 3 raffles sessions and a members draw are conducted weekly. The club is designed so that it can be sectionalised and hold four different functions at the same time. There is no permanent bistro. A caterer provides meals for social evenings and bowling carnivals To provide the necessary service to members and visitors and efficiently staff the club has seven paid employees (2 full time, 2 permanent part time, 3 casual)

Poker machines and gambling services have produced a good stream of income, so much so that clubs generally are depending on this. Gambling activities represent a high % of the trading income. Naturally, this varies from year to year. In 2006, gambling represented 48% of trading income. In 2007, the amount was 49%, and 2008 was 49% again. However this % will not be achievable for 2009, as a result of the drought conditions in the Riverina and the general recession for Australia.

During the Club's history, contributions have been made to schools, sporting bodies, registered charities and other worthwhile organisations, such as booklets advertising the area and district and publications that are circulated throughout N.S.W. eg "Jewell of the Newell Highway" (Finley is on the Newell highway.)
