- (f) The number of NSW service users is underreported for 2002-03 and 2003-04 because of low response rates.
- (g) Victorian 2003-04 data are reported to be significantly understated because errors in the 'date of last service received' and lower than expected response rates have led to under-counting of service users.
- (h) Due to updates in NT agency sector information, 2003-04 data for respite service differ to those published by the AIHW in the following report: *Disability Support Services 2003-04: National Data on Services Provided Under the Commonwealth State/Territory Disability Agreement*.
- (i) Australian Government administered services classified as 'government' are not provided by the Australian Government but by organisations classified as Australian Government related, such as universities.
- (j) Data for 2002-03 are for the period 1 January 2003 to 30 June 2003 only.
