Two simple random samples - one of Year 6 from Northern Territory government primary schools and one of Year 5 students from government and non-government schools, stratified by student ability.

The major sample is from Year 6 students as requested by the Territory during the Phase One consultation, because that is the year level of Territory-wide testing. The minor Year 5 sample of 200 will be used as links within the Territory to the overall sample selected from students in the sixth year of schooling, across States/Territories. Through such intra-Territory links, the equivalences will be maintained.
